Upon the First Completion and the Second Completion of the said agreement, Get Famous or its nominee will receive the Convertible Notes in an amount of RMB85,000,000 (equivalent to approximately HK\$96,754,000) and an amount not more than RMB42,936,000 (equivalent to approximately HK\$48,873,000) respectively.
